



Terms & Conditions TIOsignals

1. SUMMARY

- 1.1. This offer is for new clients and existing clients of TIOMarkets who use the TIOMarkets trading app, TIOsignals, on Android or Apple.
- 1.2. TIOMarkets' signals mobile application is available for download as a free product on both Google play and the IOS app store
- 1.3. All signals are provided by Trading Central SA, a regulated entity in France. Headquarters: 11 bis rue Scribe, 75009 Paris. Registered in Paris under the number 423 512 607
- 1.4. Free users of the app will be entitled to 3 free trading signals per day
- 1.5. A premium service is available for clients after depositing 500 USD (or currency equivalent) into their wallet.

2. HOW CAN I SUBSCRIBE TO THE PREMIUM SIGNAL SERVICE?

- 2.1. To access all signals on all instruments per day, user will need to deposit \$500 (or equivalent) into a TIOMarkets trading account. Visit www.tiomarkets.com for more information and click REGISTER.
- 2.2. In order to activate your PREMIUM signals account you will need to sign up to the application with the same email address as you have used on your trading account when registering with TIOMarkets.

3. EXISTING CLIENTS OFFER SIGN UP

- 3.1. Existing clients with the balance of 500 USD will have to access the TIOsignals premium signals.
- 3.2. The client wallet should exceed \$500 to gain access to the PREMIUM service and full signals
- 3.3. If the client wallet falls below \$500, the PREMIUM service will be downgraded to FREE, giving the client 3 free signals daily
- 3.4. The trader should sign up to the application using the same email address as the one used to sign up for a trading account with TIOMarkets in order for the system to recognise the client.

4. GENERAL TERMS

- 4.1. TIOMarkets' signals are provided by Trading Central. TIOMarkets is not responsible for the production or the outcome of any given signal.
- 4.2. TIOMarkets reserves the right to amend these terms and conditions at any time without notice.
- 4.3. TIOMarkets has the right to withdraw without prior notice the Promotion or profit gained if: a) a breach of these Terms and Conditions occurs; b) Upon expiration of the Promotion, the trading terms are not satisfied; c) The Company has
